<p>A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.</p>	<ol style="list-style-type: none"> <li>1. Students are carefully screened prior to admission to reduce the risk of unsafe behavior that would require restraint while in the program.</li> <li>2. Students who are in multiple restraints due to unsafe behavior are reconsidered for appropriateness by the treatment team. In these 2 cases, both students were discharged and recommended to a higher level of care.</li> <li>3. Staff are continuously trained on non-physical, trauma responsive intervention techniques to avoid the need for restraint in potentially unsafe situations.</li> <li>4. We do not utilize involuntary seclusion as it is inconsistent with our trauma responsive clinical model.</li> </ol>
